AKTA CAP DAGANGAN 1976
(Akta 175)

PENGIKLANAN PERMOHONAN UNTUK MENDAFTARKAN
CAP DAGANGAN

Menurut seksyen 27 Akta Cap Dagangan 1976, permohonan-permohonan untuk mendaftarkan cap dagangan yang berikut telah disetujuterima dan adalah dengan ini diiklankan.

Permohonan-permohonan untuk mendaftarkan dalam Bahagian A dalam Daftar ditandakan dengan Nombor Rasmi yang tidak diiringi dengan apa-apa huruf. Permohonan-permohonan untuk mendaftarkan dalam Bahagian B dikenali dengan huruf B yang ditambahkan kepada Nombor-nombor Rasmi.

Jika sesuatu permohonan untuk mendaftarkan disetujuterima dengan tertakluk kepada apa-apa syarat, pindaan, ubahsuaian atau batasan, syarat, pindaan, ubahsuaian atau batasan tersebut hendaklah dinyatakan dalam iklan.
